Obtaining a REAL ID Driver's License

REAL ID is a federal standard for stateissued driver's licenses and identification cards, applicable across all U.S. states, U.S. territories, and the District of Columbia. You will need a REAL ID to:

- Board commercial aircraft
- Access some federal facilities
- Enter a nuclear power plant

If you do not produce a REAL ID at these locations, you will not be allowed to pass through security checkpoints.

A REAL ID cannot be used for international travel, including crossing into Mexico or Canada, or for international cruises. A valid U.S. passport is still required for these purposes.

OBTAINING YOUR REAL ID:

To obtain your REAL ID driver's license, you must visit a Maryland Motor Vehicle Administration (MVA) office in person and provide required documentation.

REQUIRED DOCUMENTATION FOR U.S. CITIZENS OR PERMANENT RESIDENTS:

1. Proof of Identity

- a. Birth certificate (original or certified copy)
- b. Valid U.S. passport
- c. Permanent Resident Card
- d. U.S. Adoption records (with full name and date of birth)
- e. Certificate of Naturalization
- f. Certificate of Citizenship

2. Social Security Number (SSN)

- a. Original Social Security card (or official duplicate)
- b. W-2 form or pay stub (displaying your name and full SSN)
- c. SSA-1099 or Non-SSA 1099 form (displaying your name and full SSN)

3. Proof of Address and Maryland Residency (must provide 2)

- a. Maryland vehicle registration card or title
- b. Vehicle insurance card or policy displaying your address
- c. Utility, telephone, cable, or satellite TV bill
- d. Checking, savings, or financial account statement
- e. Property tax bill or receipt
- f. Mortgage account statement, deed, or other proof of homeownership
- g. Residential rental contract
